Road Safety and Motor Vehicle Management Rules (2022) Chapter (8)

Vehicles, Driving License and Spare Man License to operate Cross-border Transport

- 245. Regarding foreign registered vehicles entering into or passing through Myanmar or domestic registered vehicles entering into or passing through other countries according to the regional agreements, the department can conduct the following:
 - (a) Designating, changing and amending road traffic regulations.
 - (b) Designating, changing and amending the required evidences and documents for vehicles, driver and spare man.
 - (c) Designating, changing and amending types of vehicles and technical standards.
- 246. (a) The vehicle registered in the Contracting Party must comply with the following specifications when it is entering into or passing through Myanmar. It shall:
 - (1) be the vehicle permitted by the authority of the relevant Contracting Party and have completely specified evidences and documents for this vehicle.
 - (2) be types of vehicles and technical standards as specified by Myanmar based on the agreements,
 - (3) be paid fees specified by Myanmar according to agreements.
 - (b) The driver who drives the vehicles according to Sub-section (a), he shall:
 - (1) be the driver permitted by the authority of the relevant contracting party.
 - (2) have mutually recognized and valid driving license or international driving permit according to the regional agreement.

- (3) obey the existing motor vehicle laws, regulations, disciplines and directives of Myanmar.
- (4) not to transport domestic passengers and goods from one place to another during territory of Myanmar.
- (c) The spare man according to Sub-section (a), he shall have the documents issued by the authority of the relevant Contracting Party.
- 247. If evidences and documents issued by the relevant contracting party for the vehicle, driver and spare man according to section 246 are not described in English, English translation must be attached.
- 248. Concerning the vehicles loaded dangerous goods that are registered in one Contracting Party according to the regional agreement when entering into or passing through Myanmar, they shall comply with the following specifications other than those specified in Section 246:
 - (a) The vehicle shall have permission of National Road Transport Facilitation Committee.
 - (b) The driver who drives the vehicle loaded dangerous goods shall be qualified with the specifications designated by regional agreements and also have specified documents.
 - (c) Vehicle Marking, Container Marking, Tank Marking, Packaging, Labelling, Loading and Unloading shall be carried out according to the specifications of the agreement so as to be prominent that the vehicle is loading dangerous goods.
 - (d) Safety equipment and action must be fully prepared in advance in case of accident during the carrying of dangerous goods.

- 249. Regarding foreign registered vehicles which are not under the regional agreement entering into or passing through Myanmar, they shall comply with the following specifications:
 - (a) Motor vehicle, the driver and the spare man, as well as the persons who will travel with the vehicle shall have the permission of the Union Government.
 - (b) The permitted vehicles shall have completely the documents and evidences issued by the relevant country.
 - (c) The dimensions and weight of the vehicle shall be in accordance with the regulations permitted in Myanmar.
 - (d) The state of construction and maintenance of the vehicle shall comply with instructions laws, rules, regulations and directives of Myanmar.
 - (e) Application shall be submitted to relevant registration officer to obtain temporary registration in accordance with specifications. The fees specified for a temporary registration shall be paid.
 - (f) The driver shall have a valid International Driving Permit or a valid driving license issued by ASEAN member states or a valid driving license issued by countries that are mutually recognized by agreement. If the certificate or driving license cannot be presented, apply to the relevant licensing officer by submitting a valid driving license issued by the relevant country in order to obtain a temporary driving permit. The fees specified for temporary driving permit shall be paid.
 - (g) The spare man shall have a certificate issued by the relevant country.
 - (h) Myanmar's existing traffic law, rules and regulations shall be obeyed.

- (i) The vehicle shall not be driven without a temporary vehicle registration number issued by the relevant registration officer.
- 250. Regarding vehicles registered in department entering into or passing through other countries, transport operators:
 - (a) shall apply to get the approval of the National Road Transport Facilitation

 Committee.
 - (b) shall carry out to get the necessary documents and evidences for vehicle,driver and spare man specified according to agreements.
 - (c) shall pay the fees mutually agreed by Myanmar and contracting party or contracting parties,
 - (d) shall carry out in accordance with existing laws, rules and regulations in Myanmar when transporting goods and passengers. Also, the existing laws, rules and regulations in relevant contracting party or contracting parties shall be abided.
 - (e) shall be responsible for drivers and spare man to be in compliance with existing motor vehicles traffic laws, rules and regulations designated by contracting party or contracting parties.
 - (f) shall apply to get permissions of National Transport Facilitation

 Committee of the relevant contracting party or transited contracting

 parties for the motor vehicle carrying dangerous goods.
 - (g) shall carry out for the driver who will drive motor vehicle carrying dangerous goods to complete the requirements identified according to the agreement.

- (h) shall perform Vehicle Marking, Container Marking, Tank Marking, Packaging, Labelling, Loading and Unloading according to the specifications of the agreement so as to be prominent that the vehicle is loading dangerous goods.
- (i) shall prepare activities in advance in case of accident during carrying of dangerous goods. Safety equipment shall be prepared for activities in advance in case of accident during carrying of dangerous goods.
- 251. A relevant registration officer assigned by the department shall,
 - (a) inspect the vehicles entering into or passing through Myanmar whether they are in compliance or not with the specifications.
 - (b) inspect the vehicles entering into or passing through foreign countries whether they are in compliance or not with the specifications of Rules, Section 250.
